Inclusion In The Workplace

Inclusion is a right, not a privilege for a select few. It simply means to embrace. Embrace all that the person is and all that the person can aspire to be.

The aim of inclusion is to embrace all people irrespective of the extent of their abilities and giving equal access and equal opportunities to them so that they flourish to the best of their potential. It is not limited to only encouraging people, but is expanded into acceptance and engagement in all social activities and roles.

Inclusion is a right, not a privilege for a select few. It simply means to embrace. Embrace all that the person is and all that the person can aspire to be.

And we at Karachi Vocational Training Centre cherish this journey of our students that not only is a metamorphic experience for them but a learning involvement for their teachers as well. We see the MORE in our students. We only see the last 7 letters in the word disABILITY. As Robert Hensel puts it, "there is no greater disability in society, than the inability to see a person as more."

Our family counseling 'empowers' families to integrate their children into their social circles, be proud of their achievements and not to focus on what they cannot do but focus on what they can do.

KVTC indulges in vocational rehabilitation that enables the child to learn a trade, a skill so that he is gains employment and is 'included' in the mainstream society. We prepare our students in life skills so that they learn how to develop friendships leading to peer models, problem solving skills and developing a positive self-image.

Our social consciousness has to be reevaluated by showcasing capacity building. This can happen only when all children are given equal opportunities for education – education that compliments each child's learning style and allows him to exhibit his true potential. At KVTC we treat all students with the same esteem by designing programs that caters to all learning styles.

We promote equity by providing them state of the art tools and resources in each skill so that at par training can be achieved and when the student goes on job, he is able to handle the resources proficiently. But to achieve equitable and inclusive placements, collaboration of all stake holders must be foremost. We still require companies/employers to come forth and take responsibility of hiring the differently abled of the society.

Intellectually challenged students are the ones who face most difficulty in getting hired, because again the stigma attached that these people cannot comprehend instructions and execute tasks hinders the 5% employment quota in Sindh that has been set by the Government. We are rectifying this mindset by vocationally training our students in 5 textile units, carpentry and automotive spray painting even through a virtual simulator, but still there are no jobs in these sectors

for the differently abled. The brands of wooden accessories and textile are not coming forward to hire the special people who are carpenters, tailors, machine embroiders, block and screen printers and do exemplary zari work. It is high time that the industry sets the ball rolling for inclusion & starts hiring these talented people.

BECAUSE

Our specially abled students daily prove that

- O People with intellectual challenges CAN be vocationally trained.
- O They DO NOT require medication before they can perform vocations.
- They ARE ABLE to comprehend and follow instructions.
- O They CAN hold down their learning well enough to ENGAGE IN EMPLOYMENT.

We are determined to exuberantly continue ENABLING THE DIFFERENTLY ABLED, because 'Determination has NO disability.' If one is able then all are able.



As intellectual disabilities are not illnesses, there are no treatments per se. Instead, interventions focus on identifying abilities and limitations. The goal is to provide sufficient supports that maximize each person's functioning. KVTC is the only centre in Sindh that offers a holistic solution to all rehabilitation needs of intellectually challenged persons and involves the 3 stages of rehabilitation:

Exploration

Understanding

Action

Family Counseling

As a Senior Clinical Psychologist at KVTC, what I have observed that our trainees parents/caregivers do not or have a very minimal understanding and knowledge of their child; they lacked educational skills to stimulate the ability to socialize with their child; unaware of non-violent strategies to manage the conflicts that may result in decreasing the child's learning performance; increasing the school absences and the risk of having a bad behavior.

During the initial assessment sessions with the family and with the trainees, it became evident that there was an enormous amount of tension and anger in the families. They believed, that they had done all that they could to help their child and were at a loss as to what to do now. On the other hand, children felt that their parents were being intrusive and controlling. "Nobody loves me or understands me."

The most valuable aspect of family counselling sessions is removing the 'blame' label from any specific member of the family and approaching the problems from a family perspective. ??

The said issues are certainly not uncommon, but are examples of situations in which family counselling sessions can be of benefit to the individual child and to the entire family. Family counselling sessions can provide a means of approaching these problems in a non-threatening and caring way so that all members of the family system can feel that their concerns are being heard and each family member can participate in problem solving.

As with physical disabilities and psychological issues; the presence of mental deficits affects the whole family. The child with intellectual deficits often concurrently has social and emotional difficulties that affects school performance, peer relationships and family relationships. There is often yelling and screaming, tears of frustration and anger between parent and child.

Family counselling sessions offers a platform through which many of these issues can be brought to the surface. Often parents are unaware of how their child feels about his or her intellectual deficits and they are not even remotely aware of the pain they go through. Similarly, the child is often unaware of how his or her parents and siblings feel about the effect that the child's disability has on the family. Many of these issues come out during therapy and family members can learn to deal with these many factors. Also, family counselling can provide parents and children with successful strategies rather than fighting over homework, restriction, punishment, etc. The most valuable effect of family counselling is its ability to reinforce and strengthen family bonds. Family counselling can draw the family closer together so that family members can recognize it as a strong and healthy body that is able to effectively problem solve for all members of the family unit.

This involves the treatment of sensory disintegration disorder through state of the art sensory space helping individuals develop and engage their senses in a safe environment.





SPEECH THERAPY

Facilitates students who have difficulty in communication, eating, drinking and swallowing. It provides oral exercises for the strengthening of mouth muscles, corrects articulation problems in people with physical or mental dysfunctioning, Developmental speech and language delay, Expressive language disorder, Receptive language disorder, Autism spectrum disorder, apraxia, Dysarthria & Intellectual disability. With the help of the Speech Language Pathologist the trainees participate in therapeutic exercises regularly.




PSYCHODIAGNOSTIC & COUNSELING

Clinical psychologists diagnose and identify developmental, emotional and behavioral problems.

Through observation, interviews and tests, the psychologist will diagnose any existing or potential disorder.

Counseling enables the students to perform to the best of their abilities with encouragement and motivation.





Teaches fundamental movements, development of psychomotor skills & core muscular movements. The outcome is the enhancement of agility & balance coordination (ABC). Students have won medals in regional, national and international competitions, such as the Special Olympics. The Sports program is based on a UK certified curriculum.

VOCATIONAL SKILLS

Through vocational skill training we are indulging in rehabilitating people with intellectual challenges.





FUNCTIONAL ACADEMICS

Functional Academics teaches students skills that are required in daily living through academic concepts.

- Students are taught the basic to advanced concepts of Mathematics, English, Urdu, General Knowledge, Islamiat & Ethics.
- Ensures students learn content and acquire knowledge.
- · Creates a personalized learning experience for each student.
- Maximizes student learning efficiency.

JOB PLACEMENT

Over 500 KVTC alumni has been employed in various industries of Pakistan since 1991.



TEXTILE SKILLS

The general work place in Pakistan still has a long way to go in terms of being accessible to people with physical disabilities, whereby most employers are reluctant to hire intellectually challenged people because they perceive them to have limited or insufficient capabilities to perform jobs. This lack of awareness results in even stronger barriers for intellectually challenged people who are almost never considered for employment. While KVTC has had unprecedented success in this area, we feel that we can find employment for more intellectually challenged people through the set up of small-medium enterprises, based on the skills they learn at the centre, and the manufacture and sale of items produced and marketed by intellectually challenged people themselves.



TECHNICAL SKILLS

Technical skills nurture empowerment through practical training where the person learns to master the intricacies of the respective trade.





It was a fine morning of April 21st 2019, in the city of Osaka, Japan, a team of 3 differently-abled kids from Pakistan raised the Pakistan flag high with pride and made history by clinching 3 gold medals in the 17th International WATA Taekwondo Championship. It may sound simple but there were years of hardwork, practice, perseverance, and dedication that made this day a reality.

KVTC has been participating in sports since 1994 when the first batch of 55 trainees from KVTC represented Sindh in the National Games held in Islamabad. KVTC always makes sure to play an active role in every sports competition on regional, national, and international level. KVTC is the only institute that has won 1327 medals in different domestic and international sports competitions in the past 28 years. The list of achievements of our talented trainees is long enough that an entire book could be written if I go one by one. So I will try to give you an overview of what we have done so far.

In 1995, KVTC started providing Para-Taekwondo training in the Centre under the Paralympics Taekwondo Wing and since then we have been training our students and preparing them for competitions. Pakistan did not have any representation in the International WATA Taekwondo Championship until last year as three trainees from KVTC made it to the 13th WATA Taekwondo Championship 2019. It was the first time that a team from Pakistan participated in an international Para-Taekwondo competition. KVTC's trainees not only represented Pakistan but they participated with 24 other teams coming from countries all over the world. They competed with them and won three gold medals in their respective categories.


Our students have made us proud in almost every sport and not just Taekwondo. KVTC participated in World Games (Special Olympics) held in the United States in 1999 and won gold medals in swimming, table-tennis and basketball. Recently, a Unified Cricket Championship was organized in Srilanka in 2018 where our student Abdullah Imtiaz was part of the team that represented Pakistan and brought the trophy home.

Coming back to Pakistan, here in Karachi, Bazil Shaheed Taekwondo Champions Trophy is held each year from the last seven years. It is an interschool competition, in which different schools, special needs schools, and clubs participates. KVTC has been winning the Bazil Shaheed Trophy from the last six years.

TOUR TO JAPAN




A memorable journey of hope, courage, and determination

Yes, it was a big challenge for us as we have to make all the arrangements for our differently abled trainees and make sure they feel comfortable during the whole trip. It was a challenge for our trainees too, as being away from home, from their families, and travelling abroad is not easy even for many of us. There was a problem of halal food in Japan and so we took packed halal food from Pakistan and even shared with our Japanese fellows. Here I would like to appreciate the parents as they have two hundred percent trust on KVTC. They showed complete confidence in our staff and were happy that the organization cares for their children in every aspect. One thing I would like to mention here is that all the expenses incurred, from preparations for the game, during their stay in Japan to coming back home, was paid by KVTC. We made all the arrangements on our own without any government support or private sponsorship.

Our students had no foreign travelling experience prior to this trip, so for us the excitement of the journey started from the very moment we left for the airport. We were given a warm welcome at the Osaka airport from the officials of WATA. Back home we had already done enough practice sessions at the centre and so we decided to enjoy our time in Japan. We had two days before the 4-day competition and we tried to make the most of it. Our boys went out for shopping, visited one of the famous parks of Osaka and Disneyland. They experienced air travel, staying in a new country, and performing among world's best teams at an international level competition. And after all this, these boys made us all proud by performing beyond expectations and clinching 3 gold medals each in their respective categories. It was a big win not just for us but for Pakistan.

MAKING IT **HAPPEN**





In our opinion, the accompanying financial statements present fairly in all material respects, the financial position of the Centre as at June 30, 2020 and of its financial activities for the year then ended in accordance with the approved accounting and reporting standards as applicable in Pakistan.

Basis for Opinion

We conducted our audit in accordance with the International Standards on Auditing (ISAs) as applicable in Pakistan. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Centre in accordance with Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants as adopted by the Institute of Chartered Accountants of Pakistan (the Code), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidences we have obtained are sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

The Executive Committee of the Centre is responsible for the preparation and fair presentation of the financial statements in accordance with the approved accounting and reporting standards as applicable in Pakistan, and for such internal control as the Executive Committee determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Executive Committee is responsible for assessing the Centre's ability to continue as going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Centre or to cease operations, or has no realistic alternative but to do so.
